## GENERAL INFORMATION

**SUPRA-T&O Six Iron** is an excellent way to quickly correct iron deficiencies in turf and ornamental plants. **SUPRA-T&O Six Iron** is formulated to be safe and compatible with most amine based herbicides.

## DIRECTIONS FOR USE

**SUPRA-T&O Six Iron** will disperse in water with minimal agitation. It can be tank mixed with most pesticides and fertilizers. Always make a small-scale test to assure compatibility. Use of a surfactant is recommended when applying to plants with waxy leaf surfaces. Follow the mixing sequence: 1. Water; 2. **SUPRA-T&O Six Iron**; 3. Other fertilizer; 4. Pesticide. Spray volumes can range from 0.5-4 gal. per 1,000 sq. ft. If mixing with amine formulations, a spray volume of greater than 2 gal. per 1,000 sq. ft. is recommended.

## RECOMMENDED RATES


**Warm and Cool Season Grasses:** Apply 2-8 fluid oz. per 1,000 sq. ft. three to five applications per growing season.

**For Bentgrass,** do not exceed 5 fl. oz. per 1000 sq. ft. per application. Do not exceed 3 fl. oz. per 1000 sq. ft. on centipedegrass if temperatures are above 90°F.

**Bermuda Grass:** Apply 4-10 fl. oz. per 1,000 sq. ft. in three to five applications per growing season.

This product may be corrosive to aluminum, mild steel and brass. Store in HDPE, fiberglass or stainless steel containers. Use only stainless steel, P.V.C. or polypropylene fittings. **Storage:** Store in a cool place in original container in a locked storage area inaccessible to children, pets, domestic animals or wildlife. **Container Disposal:** Do not reuse empty containers.
